Niax Silicone L-838 is a low potency silicone stabilizer used in the production of flexible slabstock foam. It offers optimum stabilization with very good foam porosity, and fine and regular cells in medium to high density conventional foam. L-838 has demonstrated broad processing latitude with virtually all grades of conventional flexible foam and across a variety of machine types. L-838 may also be considered for use in TDI and MDI viscoelastic foam formulations where low potency is required.
